Agreements

I agree that my child will arrive on time for his or her class and be picked up at the end of the school day on time.

I agree to permit my child to take part in school field trips. If not attending filed trip child may not be permitted to attend school on that day.

I agree to attend parent meetings, parent-teacher conferences, and classroom observation. The school assists the child in his or her development; communication among the adults around the child is necessary.

Contract: I understand that children are admitted for the full academic year and that my agreement to pay for the school year is not subject to adjustments of illness or absence. I may withdraw my child by giving **written** notice to the School before withdrawal.

Children of the Earth Montessori School retains the right to dismiss any student within the 8 week period from his/her first day of school whose progress or conduct is deemed unsatisfactory and/or whose influence does not serve the best interest of the students and school. A student can also be dismissed from the program at any time during the school year.

If a student is dismissed from the program all registration fees are nonrefundable. The number of days of the student will be calculated. Any money still owed to Children of the Earth Montessori School LLC by the parent/guardian will be due within 7 days of the student's dismissal. If a refund is owed to the parent/guardian, it will be issued via a school check through the mail within 7 days of the student's dismissal.
